The Dean has been receiving questions regarding the article on the Board of Governors' discontinuation of academic programs at UNC Charlotte in the Charlotte Observer. She assured everyone that no teacher education programs are being shut down at UNC Charlotte at this time. The actions taken by the Board of Governors involved correcting the inventory of programs at UNC Charlotte to reflect how those programs are actually

delivered (e.g., French education is not a stand-alone degree but instead a combination of a major in French and a minor in education.)

- College of Education Diversity Scorecard
 A goal in our Strategic Plan is to recruit and retain a strong diverse faculty and student body.
 A new tool from the ADVANCE office will help us monitor our progress across racial groups and genders and will show how we compare with our national peers. The Dean discussed the data from the PowerPoint presentation. See attachment at end of minutes for department discussion. The Dean requested everyone's participation in future surveys.
- Looking Forward campaign/ development update: HOLD THE DATE MAY 7, 2011
 The Dean stated that a search is underway for a new Director of Development for the college. We will receive excellent support from the Development Office with a temporary consultant to work with us for about 4-6 weeks. Our campaign will go forward. A College of Education 40th Anniversary Gala is being planned for May 7, 2011 at the Harris Alumni House. Mark your calendars.

Approval of structure/ major concepts of the revisioned College of Education Conceptual Framework Update.

Teresa Petty presented the updated outline from feedback from meetings held with the Professional Development School, departmental meetings and the blog. The complete Conceptual Framework document will be developed around the structure/ major concepts presented today (pending approval) and will be introduced to the faculty in March. Lyndon Abrams called on faculty to vote to accept the elements of the work. Faculty voted unanimously to accept the elements.
