#### 7. NC licensure requirements for methods instructors - Amanda

#### 8. Laura Hart:

## • Discussion on program grades

There are questions around the grade of C in our catalog. We need common language descriptions so it won't need updating so often. We need to be more explicit about requirements. Laura will meet with the program coordinators to look closely at the programs.

## • Phasing out Turn It In in TaskStream

It will still be available through Spring 2015 in TaskStream. It can be used through Moodle.

## • Sharing edTPA data with programs

Laura shared the data with chairs who will share with their faculty. 78% has passed with 90% of ELED making their target. MDSK is doing well too.

#### 9. Status check: clinical faculty promotion reviews

Jim Watson and Sue Rebich will be going through the process this year. Belva asked whether the clinical person selects the external reviewer and who can be an external reviewer, outside of the department or college or out in the community? Ellen stated that since this is an informal process, we should be flexible in this.

## 10. Federal regulations on teacher prep and our responses to it

There are a lot of complex issues around these proposed regulations. States will rate the teacher programs within their state. They also want employment outcomes, teacher placement in high needs schools and teacher retention in difficult to staff schools and
