Approval of Minutes

Suzanne Lamorey made the motion that the September 14 minutes be approved. Deana Deason seconded the motion. Minutes were approved by common consent.

M. Ed. Blueprint

The Blueprint was approved by the Department and submitted September 17 to Vicki Jaus and sent on to the state for approval.

Next timeline:

- *Condensed 7400 (7400/7600).*
 - *Due on October 15 to Vicki: Short Form with program of study.*
- *Three new SPED courses.*
 - *Due in November: Get SPED, Library, and CHFD approval*
 - *Due on December 1 to Vicki: Long Form with course outlines and syllabi.*

MAT Consideration

An MAT would assist in getting an initial license quickly, so students could then move into advanced licensure. This is what our graduate programs would look like:

- 1. Graduate Certificate (27 hours)*
- 2. Graduate Certificate (27 hours, Phase I - initial license) to MAT (12 hours, Phase II - advanced license)*
- 3. M.Ed. (39 hours, advanced license)*

Discussed pros and cons and addressed the concern of increased faculty load. Suzanne will look into whether a student can move from the M.Ed. to the MAT.

The Phase II proposal (blueprint) needs to be submitted by November 1 for Fall 2011. The Long Form should be completed in Dec/Jan.

- *Timeline: 10-14 business days, 6-8 weeks delivery to bookstore*
- *Can make your own title*
- *You can put up to 30% of your own material in them*
- *You can change content as needed to fit your courses; just takes 14 days*
- *Can proof electronically. A desk copy will be sent at no cost*
- *State standards can be included in books*
